## RENTAL AGREEMENT WAIVER

I/we acknowledge that by using the Community Center/Conference Room of the Grandwood Park Park District ("facility"), I/we waive and release all claims for injuries that may arise during my/our use of the Park District facility. I also indemnify and hold the Park District harmless as provided herein.

In using the facility of the Park District, I/we recognize and acknowledge that there are certain risks of physical injury and I/we agree to assume full risk of any injuries, including death, damage, or loss regardless of severity which I/we or any other user may sustain as a result of participating in any and all activities connected with, or associated with, my/our use of the facility. I/we understand that not all hazards and dangers can be foreseen. Depending on the particular activity, certain risks, dangers and injuries due to inclement weather, slipping, falling, carelessness, horseplay, premises defects, inadequate or defective equipment, and other circumstances inherent to recreational programs and facility use exist. The Grandwood Park Park District cannot guarantee absolute safety. I/we agree to waive and relinquish all claims I/we may have as a result of using the Park District's facility against the Grandwood Park Park District and its officers, agents, servants, Board of Commissioners, individual or elected officials and employees ("Covered Entities") and hereby covenant not to sue the Grandwood Park Park District or any other Covered Entities.

I hereby fully release and discharge the Grandwood Park Park District and its Covered Entities from any and all claims from injuries, including death, damage or loss which I/we may have or which may accrue to me/us on account of our use of the Park District's facility. I/we further agree to indemnify and hold harmless and defend the Grandwood Park Park District and its Covered Entities from any and all claims resulting from injuries, including death, damage or loss, sustained by any third parties (including guests) or the Park District or by me/us, caused in whole or in part by me/us or a third party (including guests) or arising out of, in connection with, or in any way associated with my/our use of the facility.

The Grandwood Park Park District makes no warranty or representation about the condition of its facility, which I/we have examined and have concluded adequate for my/our required purposes and I/we agree that this waiver, release, and indemnity shall be effective regardless of the condition of the facility. I/we agree to be responsible for the costs to repair any damages to the facility, or the property of others, which occurs during my/our use of the facility.

I have been advised that the Grandwood Park Park District does not carry medical accident insurance for injuries sustained in its facility.
