Board of Commissioners / General Session Minutes

February 8, 2023 / 6:30 p.m.

1. Call meeting to order / Roll Call / Pledge of Allegiance

- President Carlson calls the meeting to order at 6:30 p.m.
- Roll Call: President Carlson (Present), Vice President Castro (Present), Commissioner Nichols (Present), Commissioner Baker (Absent), Commissioner S. Carlson (Present)
- President Carlson asked visitors from rugby team to lead the Pledge of Allegiance.

2. Lake County Covotes

New Board members, Jeff Jewel – President, Sean Pearce – Vice President, and Lisa Jewell – Ombudsman were present to introduce themselves to the Board. Items discussed: clarification on how much space in the pole barn is allotted to them, they are aware of volunteer/community service required for discount of field rates, an extra key for lights needed, interested in hosting a tournament (once a date is determined Steve will ask Tim Smith about parking for the tournament), asked about possibility of having a concession stand, and possibly starting a youth program.

WSRA finalized agreement to add Lindenhurst Park District. Information regarding WSRA Fundraiser on March 24th shared with the Board.

7. Treasurer's Report (Kathy Atkins)

Treasurer's Report presented to the Board. President Carlson calls for a motion to accept the January 2023 Treasurer's report, pending audit. So moved by Commissioner Baker, seconded by Vice President Castro. Motion carried.

8. Parks & Grounds (Vice President Castro)

Lake County Public Works approved our request to remove the split-rail fence at Tower Park. Proposals to add a light in Lake Park to illuminate the dam and to replace an old fixture that isn't working presented. Discussion. Vice President Castro makes a motion to retain Winston Electric for a total of \$2150 to install the light at the dam and replace broken lights, seconded by Commissioner Baker. Motion carried.

9. Building & Maintenance (Commissioner Nichols)

Main room and rear vestibule painted January 18th. Proposal from Winston Electric to increase lighting in the new office discussed. Commissioner Nichols makes a motion to add lighting for new office for \$750 by Winston Electric, seconded by Commissioner S. Carlson. Motion carried.

10. Community Engagement, Special Events, & GPCA (Commissioner S. Carlson)

Update on GPCA discussed. Commissioner S. Carlson reported that he delivered the letter from the GPPD to President, Chris Gano, and Vice President, Darleen Gano, of GPCA. President Gano gave Leslie a letter stating that GPCA has a new board and will honor GPPD's request to remove all possessions from park district property and will dissolve the relationship between GPCA/GPPD. GPCA and GPCA/GPPD property discussed. Stage and sound system were paid for by both entities. GPCA Vice President Gano and Leslie Cassidy, PD Manager, went through the storage room and kitchen closet of the community center to identify GPCA possessions and GPCA has removed their all items that was the property of GPCA. Discussion. Commissioner S. Carlson added that as a 501©3 organization, there are things they may have to do with the State. Darleen and Leslie will go thru the pole barn to create a list of GPCA property.

President Carlson requests a motion to move Item #13 up in the agenda to this point. So moved by Commissioner S. Carlson, seconded by Vice President Castro. Motion carried.

Kathy reported that Mr. Morehead's attorney requested the contact info of our attorney to discuss the Transition Yard Agreement. She is now waiting to hear from either of them.

Lake County Sheriff's Department will not be able to help with security at our rentals with music. Private security or having Commissioners handle it was recommended. Discussion. Commissioner S. Carlson volunteered to handle the next rental with music – February 18th.
