Board of Commissioners / General Session Minutes

May 10, 2023 / 6:40 p.m.

1. Call meeting to order / Roll Call / Pledge of Allegiance

- President Carlson calls the meeting to order at 6:40 p.m.
- Roll Call: President Carlson (Present), Vice President Castro (Present), Commissioner Nichols (Present), Commissioner Baker (Present), Commissioner S. Carlson (Present)
- President Carlson asked Commissioner Baker to lead the Pledge of Allegiance.

2. President's Report – Administration & Government Reporting (President Carlson)

Report consisted of following topics: installation of walking path signs completed, Budget & Appropriations Ordinance filed with County Clerk, received our official inventory list of park district records from State's Attorneys office, and President Carlson will work on sidewalk markings for walking paths throughout community.

12. Land Improvements - 36622 N. Hutchins Rd. Property (Kathy Atkins)

President Carlson and Commissioner Nichols have a meeting scheduled for May 11th with Lake County to discuss parking lot project and next steps.

13. Facilities Expansion Planning Committee (President Carlson)

Walking path discussion regarding the path across Grand Avenue that we would like to attach to, however a crosswalk across Grand Avenue is needed. Commissioner S. Carlson will send a letter to Joyce Mason, and copy Carissa Casbon requesting assistance.

- Appointment of President: Commissioner Nichols nominates Nancy Carlson for the position of President, seconded by Commissioner S. Carlson. Vice President Castro nominates himself for the position of President, no second motion fails. President Carlson calls for a vote on the motion to appoint Nancy Carlson as President. After many outbursts throughout the meeting by Vice President Castro, President Carlson advised him that he is being inappropriate, and she would have to ask him to leave the meeting if

he cannot follow protocol. President Carlson again calls for a vote on the motion to appoint Nancy Carlson as President. Commissioners Nichols, Baker, and S. Carlson vote aye, Vice President Castro votes against. Motion carries.

- Appointment of Vice President: President Carlson nominates Commissioner Nichols for the position of Vice President. Angel Castro leaves the meeting at this time – stating he will be back next month. President Carlson calls for a vote on the nomination of Commissioner Nichols as Vice President. Commissioners Nichols and S. Carlson, and President Carlson vote aye. Motion carried.
- Discussion regarding re-appointing Jerry Baker as a commissioner until someone can be found to be appointed to the Board. Jerry agrees. Vice President Nichols makes a motion to appoint Jerry Baker as a commissioner, seconded by Commissioner S. Carlson. Motion carried. Oath of Office will be taken at the June meeting.
